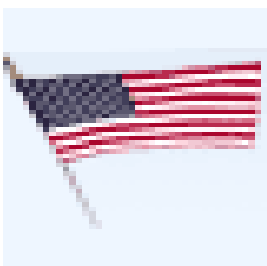
PROPOSAL TO ADDEND SCHOLARSHIP PROGRAM

Purpose: To addend the criteria of the EANGUS Auxiliary Scholarship Program to include grandchildren as eligible persons to participate in the EANGUS Auxiliary Scholarship Program. It is the consensus of the undersigned that this addendum would increase participation in the program as well as create more awareness of EANGUS Auxiliary through a wider range of participants.

The criteria currently reads:

The following persons are eligible:

1. EANGUS Auxiliary members
2. Unmarried, dependent sons and daughters of EANGUS Auxiliary members
3. Spouses of EANGUS Auxiliary members

The proposed addendum is:

The following persons are eligible:

1. EANGUS Auxiliary members
2. Unmarried, dependent sons and daughters of EANGUS Auxiliary members
3. Spouses of EANGUS Auxiliary members
4. **Unmarried, dependent grandchildren of EANGUS Auxiliary members**

The criteria further states:

Verification of membership in the EANGUS Auxiliary of the mother, father, or self is necessary for applicant to be eligible.

The proposed addendum is:

Verification of membership in the EANGUS Auxiliary of the mother, father, self or grandparents is necessary for applicant to be eligible.

The criteria further states:

There shall be no consideration whatsoever given by the judges because of rank or grade of applicant, applicant's parents, or applicant's spouse. Scholarships will be awarded on the basis of scholastic achievement.

The proposed addendum is:

There shall be no consideration whatsoever given by the judges because of rank or grade of applicant, applicant's parents, or applicant's spouse or applicant's grandparents. Scholarships will be awarded on the basis of scholastic achievement.

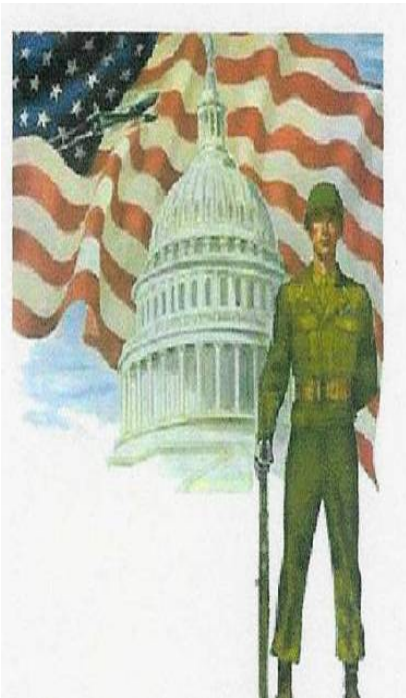

LEGISLATIVE ALERT #07-04

May 17, 2007

The Issue: Restoring Funding for the Joint Cargo Aircraft (JCA)

Immediate Action Required: Contact your Senators and urge them to provide funding for the JCA in the FY08 SASC NDAA that was removed by the HASC in the FY08 NDAA (H.R.1585)

The purpose of the Joint Cargo Aircraft (JCA) program is to procure a small cargo aircraft for both the Army and the Air Force that provides responsive, flexible, and tailored airlift for combat, humanitarian operations, and homeland defense. A Memorandum of Agreement (MOA) was signed by the Army and Air Force on 20 Jun 06, establishing an initial joint requirement. NGAUS supports procurement of the JCA.

Members of the both House and Senate Armed Services Committees have been requesting Air Force lift capabilities studies for some time, believing the Air Force has a greater requirement for airlift than it has identified in its budget request. Those studies have not been delivered.

The House Armed Services Committee (HASC) inserted language in the FY08 Defense Authorizations Bill (20 Mar 07 House Report 110-146, Section 132, page 41) prohibiting the Secretary of the Air Force or Army from obligating or expending funds for the development or procurement of the JCA until 30 days after the Secretary of Defense (SECDEF) submits to Congress a series of airlift capabilities and fleet-mix analysis studies. The SECDEF must also certify that there is a valid requirement for the JCA. The restrictive language in the House version of the FY08 National Defense Authorization Act could delay the program for up to one year, adding unnecessary cost and time to the development of a much needed, validated program.

NGAUS urges the responsible agencies to provide to the Congress final reports on all completed studies and interim reports on those studies still ongoing. Further we urge the Senate to include funding for the JCA program in the Senate Armed Services Committee and further to ensure this funding is included in the Defense Authorization conference.

Dear Senator or Representative:

The purpose of the Joint Cargo Aircraft (JCA) program is to procure a small cargo aircraft for both the Army and the Air Force that provides responsive, flexible, and tailored airlift for combat, humanitarian operations, and homeland defense. In addition to recapitalizing the Army's aging C-23 Sherpa fleet, these aircraft also represent replacement missions for ANG units that lost their aircraft as a result of the 2005 Base Realignment and Closure (BRAC).

Members of the both House and Senate Armed Services Committees have been requesting Air Force lift capabilities studies for some time. Those studies have not been delivered. Subsequently, the House Armed Services Committee (HASC) recently inserted language in the FY08 Defense Authorizations Bill prohibiting DOD from obligating or expending funds for the development or procurement of the JCA until 30 days after the Secretary of Defense submits these studies to Congress.

The restrictive language in the House version of the FY08 National Defense Authorization Act could delay the program for up to one year, adding unnecessary cost and time to the development of a much needed, validated program.

I strongly believe the responsible agencies should submit completed studies and interim reports to Congress as soon as possible, and urge the Senate to include funding for the JCA program in the Senate Armed Services Committee to ensure this funding is included in the final Defense Authorization legislation. Thank you.
